A handout was distributed to the superintendents with an update. Mr. Domingo addressed the Council concerning the new WV Safe Schools Repository web-based platform. The site will be rolled out initially to Upshur County this afternoon. The previously used ACAMS database is no longer in use. PCII has been migrated into a new IP Gateway system. PCII is still required for those previously certified. The Safe Schools database replaced ACAMS and is housed under the HSIN (Homeland Security Information Network). It is suggested that each county designate 2-3 County Asset Managers to access and keep this information updated. Those counties who elected to have Bill Bickerstaff manage updating their data will still have that option. Mr. Domingo will register the County Asset Managers into HSIN for access to the Safe Schools Database.
