This August 2015, changes were made to the WVEIS system at the State level. There were frustrations when entering new data. For now, the old system is being refined before further modifications are made to the new system. Mr. Harker has requested that the State pilot new changes gradually rather than system-wide to avoid such global issues in the future. There is currently no prediction of when they will switch to the new system. In addition to WVEIS support, the WVEIS staff at RESA provides data feeds and support to LiveGrades, School Messenger, SoftDocs and other vendors. The staff act as a liaison to the State in
